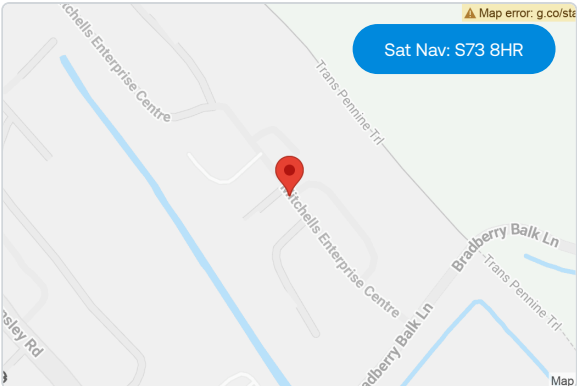

Description

The property comprises a small modern industrial estate, constructed in the 1990's to form a terrace of units with a large open servicing and parking area. The units are constructed with a steel portal frame complete with part brick/block walls and pitched roof with profile metal sheets. All units benefit from an eaves height of approximately 4 metres, three-phase electricity, separately metered gas and water.



Location

The estate is located in Wombwell approximately 3.7 miles to the south-east of Barnsley and 10 miles north of Sheffield. J36 of the M1 motorway lies approximately 2.8 miles to the south west of the property via the A6195. The property is situated within an established industrial estate and is accessed via a service road leading off Bradberry Balk Lane.
