The Western Centre is prominently located off Western Road, which adjoins Wokingham Road (B3408), providing access to the Town Centre and links to the Berkshire Way (A329). Bracknell's strategic position between the M3 and M4 motorways offers convenient access through the A322 and A329(M) respectively. These road links facilitate access to the M4, M25 and national motorway network.

Unit 2 comprises of a mid-terrace industrial/warehouse unit with two storey offices, allocated parking spaces and generous rear yard/loading area suitable for articulated lorry deliveries.
