### Description

The available premises comprise of a modern terrace industrial / warehouse unit of steel portal frame construction with part-brick and part-metal profile clad elevations, set beneath a monopitch roof incorporating translucent roof panels. The property enjoys LED lighting throughout, three-phase power, roller shutter door access and ground floor office accommodation, alongside W/C facilities and a kitchenette. Eaves height 4.55m. The estate is fenced, secured and benefits from 24 hour access.

### Location

The premises are located on the Parkway Industrial Estate and benefits from immediate access to the Sheffield Parkway via Parkway Avenue. Sheffield Parkway itself provides a link to Junction 33 of the M1 Motorway 4.4 miles away, and also connects to Sheffield City Centre 3.4 miles away. The surrounding area is a very well established commercial location, and is home to occupiers including Jack Wills, Costco, Howdens and Pentagon Sheffield.
