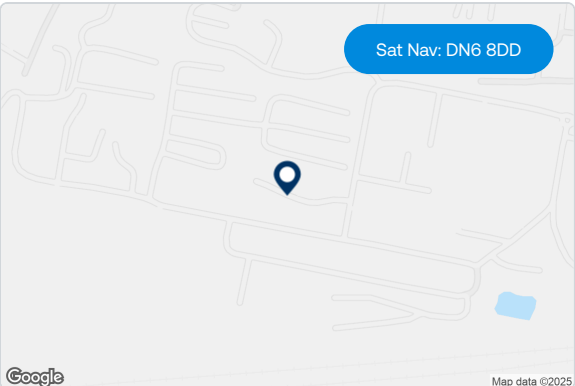
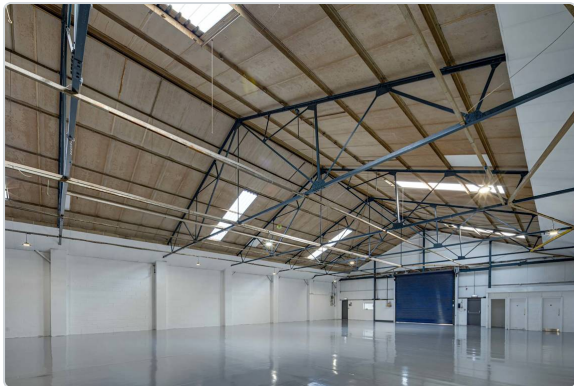

Description

Carcroft Enterprise Park comprises open storage compounds as well as 51 units designed for small businesses, starter industrial and office use. Each unit features a steel portal frame with metal profile sheet cladding on the elevations, topped by mono-pitch roofs with translucent panels. The units are equipped with LED lighting, roller shutter doors, pedestrian access doors, three-phase electricity, W/C, and kitchenette facilities. They offer a clear internal height of 4.72 meters. The estate is located within a secure gated site, which includes a manned security office and provides 24-hour access.

Location

The estate is located in the Carcroft area of Doncaster and lies just 2.5 miles to the East of Junction 38 of the A1(M) Motorway. Further, Junction 4 of the M18 Motorway is situated approximately 11 miles away to the South East. Carcroft Enterprise Park is situated approximately 6 miles to the North West of Doncaster City Centre. Carcroft Enterprise Park forms part of the established Carcroft Industrial Estate, and notable occupiers in the area include DFS Upholstery, Socotec UK, Howdens and Northern Components to name a few.
