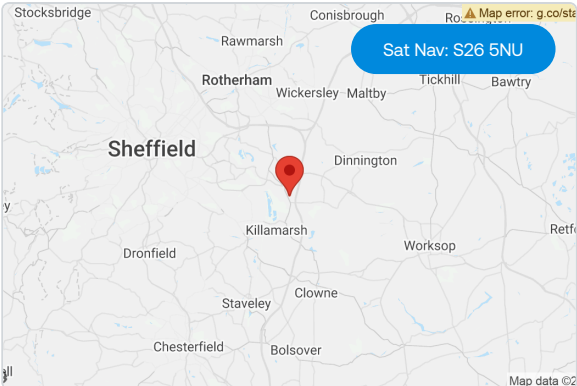

Description

The premises have recently undergone a full refurbishment and comprise a modern industrial warehouse unit of steel portal frame construction with brick block and clad elevation set beneath a pitched roof. The building benefits from 8 metre eaves, 2 x full height roller shutter loading doors and three-phase electricity. A modern first floor open plan office space provides a quality workplace for office employees and the warehouse enjoys a canteen and kitchen space beneath this. Externally, the property is set within a green, high-quality landscaped environment and has a large secured yard and dedicated car parking area.



Location

Vector 31 Industrial Estate, situated in the Wales Bar area at the boundary of Sheffield and Rotherham. The estate offers excellent access to the M1 which is approximately 2 miles away from Junction 31 as well as 3 miles further to the M1/M18 interchange towards Doncaster. Sheffield City Centre can be reached within a 9 mile drive from the industrial estate via the A57.
