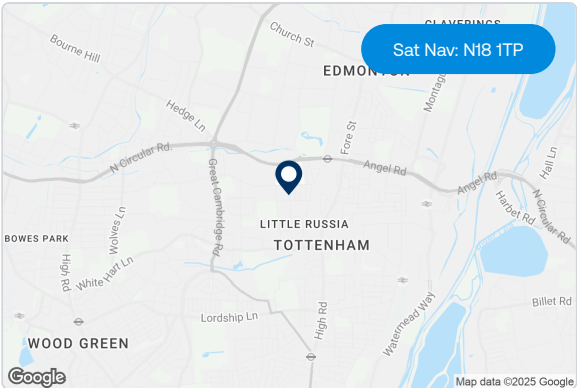

Description

The accommodation comprises terraced units of steel frame construction with brick elevations and a generous eaves height of 5m under a pitched roof. The property has a mezzanine office floor over part of it with the remainder open to the eaves.

Location

The estate is located on Commercial Road, close to the intersection of the A406 North Circular Road and the A10 Great Cambridge Road, within the London Borough of Enfield. This location provides quick and easy access to the A406 North Circular approximately a quarter of a mile to the North as well as access to White Hart Lane and main routes into Central London. These main arterial routes provide direct access to the national motorway network, M1 (J1), M25 (J25) and M11 (J4) and into Central London. White Hart Lane overground station is close by, providing a direct service to London Liverpool Street (25 minutes).
