

Description

The available property is a modern detached industrial / warehouse unit of steel portal frame construction with part-brick and part-metal profile clad elevations, set beneath mono-pitch roofs incorporating translucent roof panels. The premises comprise a specification to include lighting, three- phase power, roller shutter door access, gas blow heaters, office accommodation and an ample central service yard which is shared between Units 14 & 15. The site is fenced and secured and benefits from 24 hour access.



Location

The premises are located on Commercial Road, within the Goldthorpe area of Rotherham at the boundary with Barnsley, and form part of the established Goldthorpe Industrial Estate. Goldthorpe Industrial Estate benefits from good links via the A635 on to the Dearne Valley Parkway (A6195), providing access to Junction 36 of the M1 Motorway approximately 8.5 miles to the South West and also out to the A1(M) at Junction 37 approximately 9 miles to the North West. The Commercial Road area of Goldthorpe is home to occupiers including Aldi, Dibor, Deafinitions, Solarframe and Tek Group.
