

Description

Clarke Road is a well established and excellently located industrial estate in Milton Keynes.

Unit 23 is due to undergo refurbishment shortly providing 5,108 sq ft of high quality industrial / warehouse space.

The unit is of steel frame construction benefitting from a clear internal height of 5.3m to the warehouse area and two storey office accommodation to the front. Externally there is allocated car parking in front of the unit and shared loading provisions to the rear.

Location

Clarke Road is located within the well-established industrial area of Mount Farm which is found in Bletchley, and is positioned nearby to Stadium MK.

The estate lies adjacent to the A5 and is situated just off Dawson Road which connects to Bond Avenue and the V7 Saxon Street providing good access to the dual carriageway.

Junction 13 and 14 of the M1 are 6.6 miles and 5.4 miles away respectively providing the site with excellent access to the wider Motorway network.

Milton Keynes Central Railway Station is also within close proximity which provides the City with direct services to London, Birmingham and Manchester.
