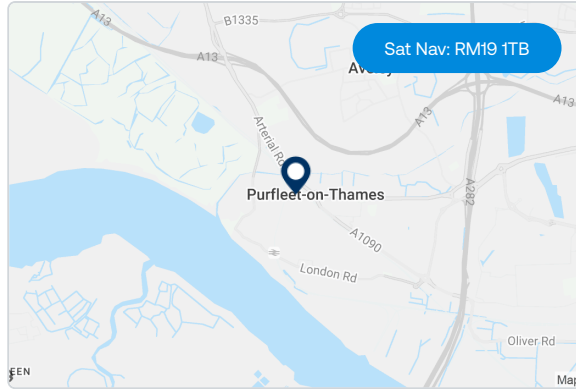

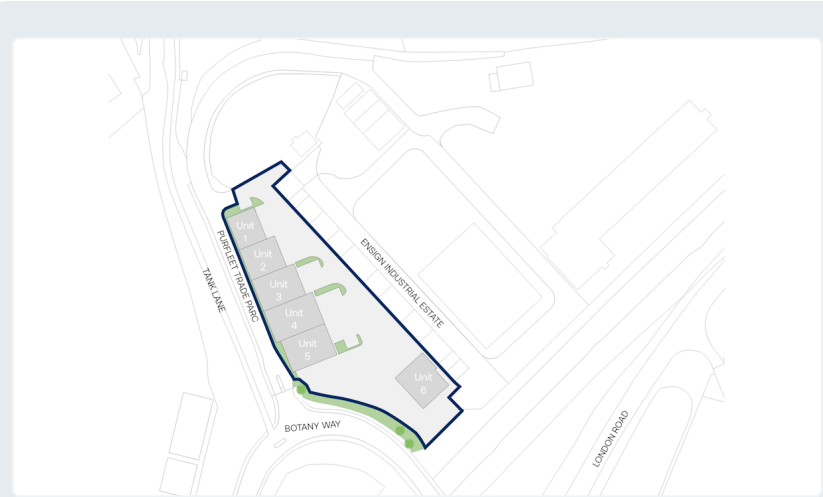
## Description

The available properties are set within a single terrace of light industrial units built in the early 1990s. The units are of steel portal frame construction with part brick/ block work and part lined profile metal cladding under a single pitch roof incorporating roof lights. Each unit benefits from a single level loading door opening onto a communal loading area.

Unit C4 is refurbished internally and can be combined with unit C5 to provide a total area of 3,651 sq ft.

## Location

Ensign industrial estate benefits from excellent road communications with Junction 31 of the M25 Motorway situated 1 mile (1.6 km) to the east of the property, offering access to the national motorway network to the north and to the south via the Queen Elizabeth II Bridge (A282). The A13, 0.5 miles (0.8 km) to the north, is a major trunk road providing quick access to Central London 18 miles (30 km) west, and east to the M25, Thurrock and Tilbury.
