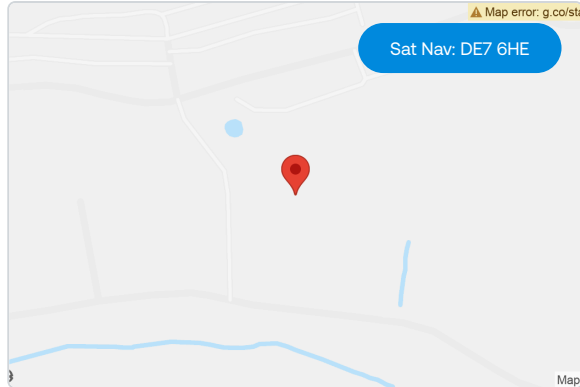

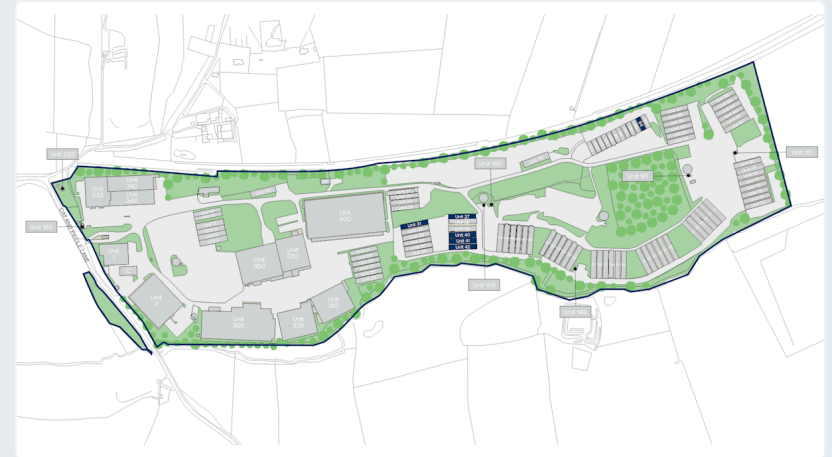
Description

Located in South Derbyshire, approximately 7 miles north east of Derby and 10 miles west of Nottingham, the estate is located on Cat Fiddle Lane close to its junction with Station Road.
