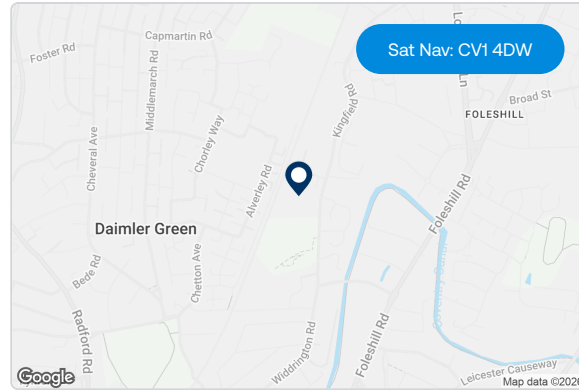

Description

The property provides a recently refurbished mid-terraced unit of steel portal frame construction with brick and lined profile clad elevations and lined roof. The property has trade entrance with a maximum height to eaves of 5.75m. There is a steel roller shutter door 4.8m width x 4.8m height and roller shutters to all doors and windows. There are male and female WC's, reception and office. Externally there is ample car parking to the front elevation.
