The site fronts the A558 Daresbury Expressway and is accessed via Manor Park Avenue. The park benefits from access to Junction 10 of the M56 motorway via the A56 to Warrington, and Junction 7 of the M62 via the A557.

Runcorn is strategically located approximately 30 miles to the south west of Manchester, 20 miles to the south east of Liverpool. Liverpool John Lennon Airport is located 11 miles to the west and Manchester International Airport is 21 miles to the east.
