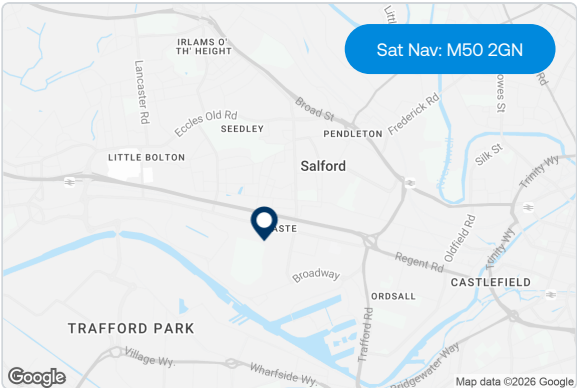

Description

Boston Court is strategically located in Salford Quays, offering excellent connectivity for businesses seeking accessible and well-connected office accommodation.

The property benefits from immediate access to the M602, which links directly to the M60 (Manchester Ring Motorway) and M62, providing fast routes to Liverpool, Leeds, and the wider North West region.
