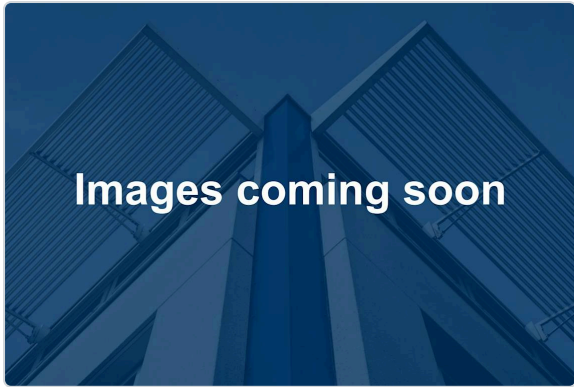

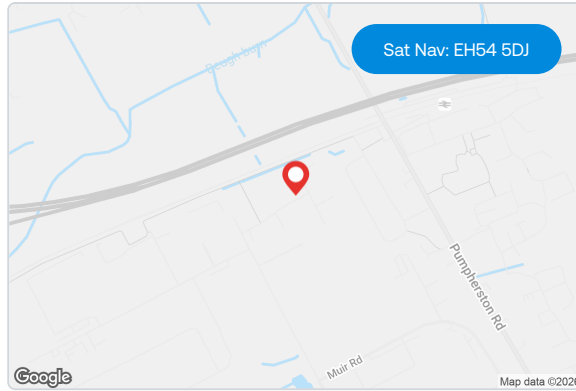

Description

This property has a prime strategic location in Livingston, between Edinburgh and Glasgow. From the visitor and staff car park at the front, pedestrians may enter through double doors leading to a reception area and mix of open-plan offices. The warehouse is of steel portal frame construction with blockwork walls and a rear elevation of steel cladding. The unit also benefits from two roller shutter vehicle doors and a large external secure yard with palisade fencing.

Location

Livingston is strategically located approximately 16 miles west of Edinburgh and 34 miles east of Glasgow and benefits from excellent transport links to both cities and the rest of Scotland. The development is situated on the west side of Houstoun Industrial Estate with frontage onto Livingston Road (A899) with easy access to Junction 3 of the M8.
