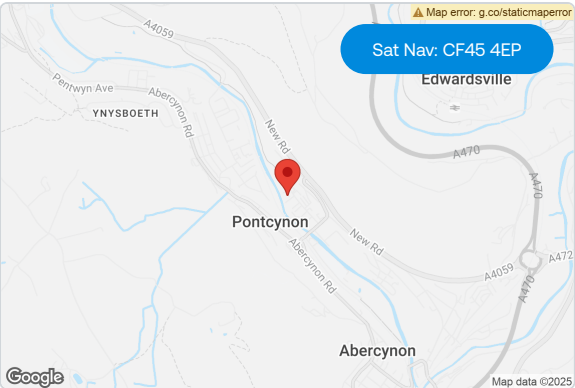

Description

These units are of steel portal frame construction. Externally, the units have steel profile cladding. The roof is a dual pitched steel cladding sheets incorporating translucent glass reinforced plastic (GRP) roof lights. Internally, the units have W.C. facilities and LED lighting throughout. The units are accessed through an electronic roller shutter door. Unit 4 offers a small side yard.

Location

Pontcynon Industrial Estate is located along the A4059 between Mountain Ash and Abercynon. The estate is 10 miles north of Junction 32 of the M4, which is accessed via the A470, having good links with Cardiff City Centre (17 miles).

To the North of the unit is Hirwaun (9 miles) and Aberdare (7.5 miles) accessed via A4059 with Merthyr Tydfil (10 miles) accessed via the A470. To the South is Pontypridd (6 miles) and Cardiff (17 miles), both accessed via the A470.

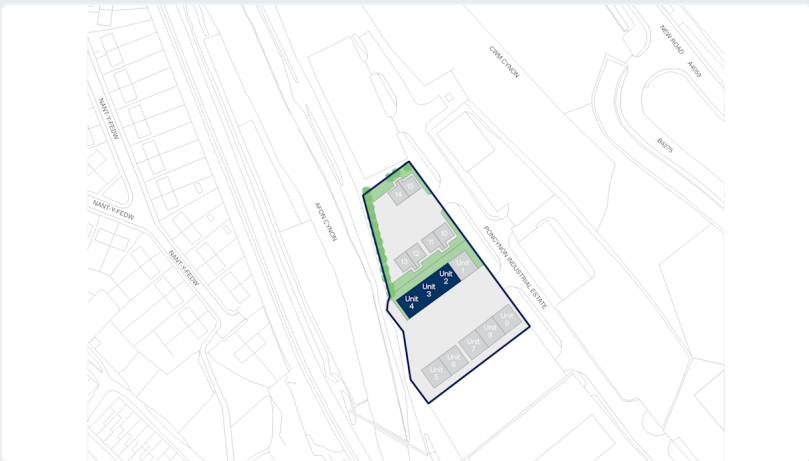
