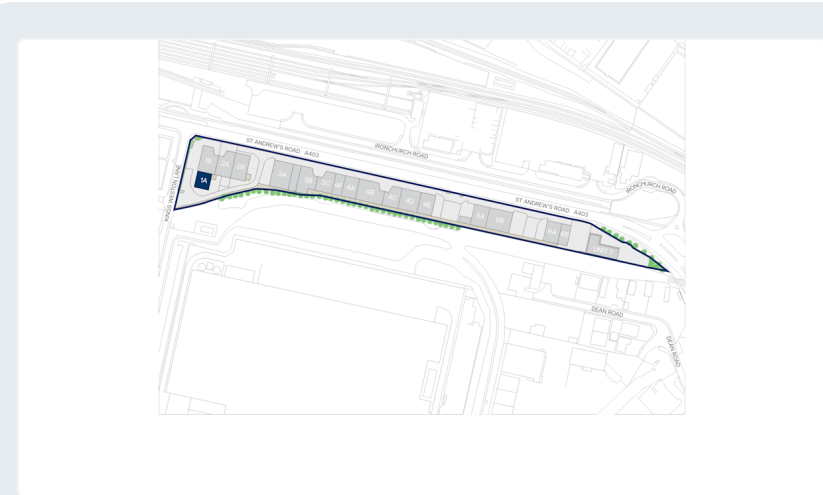
Location
