Description

Brentwood Trade Park comprises ten units off Tallon Road in an area collectively known as the Hutton Industrial Estate. The development comprises two terraces plus two stand-alone units (4 & 5). The development was completed in approximately 2016.

The units available to let are made up of two standalone buildings and one midterrace unit. All units offer open plan warehouse space and WCs. Units 4 & 5 benefit from fitted office accommodation. The units have been recently refurbished to a high quality and provide 3-phase electric, gas connection, electric roller shutter doors, dedicated parking and 6.3m minimum eaves height.

Location

Brentwood Trade Park is situated in the established commercial area of Tallon Road, Brentwood, approximately 1.5 miles from the A12 and under 4.5 miles from the M25 (J28); thus the major arterial routes to London are easily accessible with the M11 and M25 junction being within approximately 10 miles to the west, the A13/Dartford Crossing junction within approximately 15 miles eastwards. Northwards along the A12 are the major ports of Harwich and Felixstowe. The town of Brentwood, and the closer Shenfield, provide a range of local amenities and shopping facilities. Shenfield overground station provides direct rail services into London Liverpool Street with a journey time of approximately 23 minutes and also direct access onto the Elizabeth Line.
