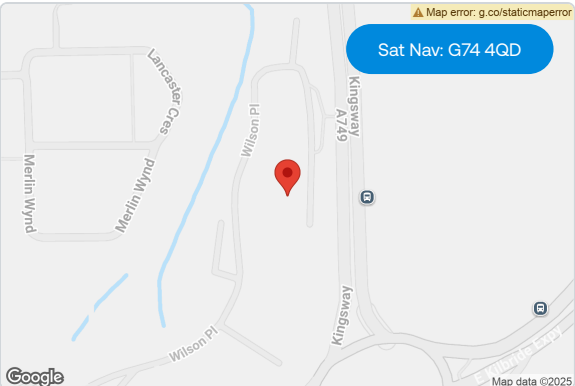

Description
