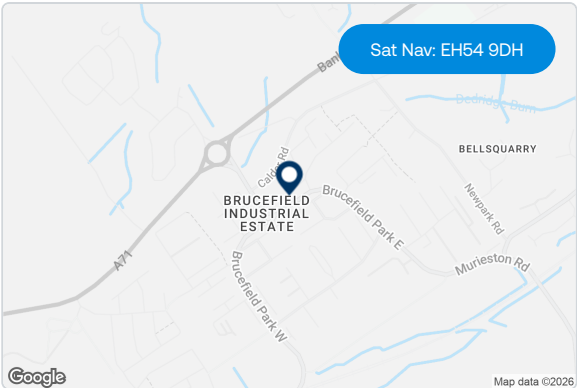

Description
